Christmas Sugar Cookie Bars

Prep Time: 1hour hr 30minutes Cook Time: 16minutes Total Time: 1hour hr 46minutes Course: Bars, Cookies, Dessert Cuisine: American, Dessert Ingredients

- 1 cup (2 sticks) salted butter softened
- 1 cup granulated white sugar
- 2 large eggs
- 1 Tbsp vanilla extract
- 1/2 tsp almond extract OR lemon/orange zest optional
- 1 tsp baking powder
- 1 Tbsp cornstarch
- $2\frac{1}{4}$ cups all-purpose flour

For the Vanilla Buttercream:

- 1/2 cup unsalted butter softened
- 2 tsp vanilla extract
- 1/4 cup heavy whipping cream or milk
- 2¹/₄ cups confectioners' sugar
- Sprinkles for decoration if using

Instructions

1. Preheat oven to 350° degrees F. Line a 9x13 light metal rectangular baking pan with parchment or foil, extending the sides of the parchment or foil over the edges of the pan. Spray lightly with cooking spray; set aside.

2. For the cookies: In the bowl of a stand mixer, cream together the butter and granulated sugar until smooth and fluffy, about 1 minute. Beat in the eggs, one at a time, mixing well after

each addition and scraping down the sides and bottom of the bowl as needed, followed by the vanilla extract and almond extract or citrus zest, if using.

3. Lastly, add in the baking powder, cornstarch, and flour and mix on low speed until just barely incorporated. Do not overmix. Spread the batter into the prepared pan in an even layer.

4. Bake for 14-16 minutes or until just barely browned. It will still look slightly underdone and very pale; this is normal and remember, it will continue finishing cooking in the hot pan outside of the oven. Cool completely, about 90 minutes.

5. For the vanilla buttercream: In the bowl of a stand mixer, cream together the butter and vanilla until whipped and combined, about 30 seconds. Alternate adding in the confectioners' sugar and heavy cream, mixing well after each addition until frosting is light and fluffy.

6. Spread the frosting evenly over the sugar cookie bars; top with sprinkles, if using. **Notes**

Almond extract or citrus zest is an optional mix-in that adds tremendous flavor. I love the combination of vanilla and almond extracts because it lends a bakery flavor, but I also love vanilla extract and lemon zest.

Sprinkles are optional and can be substituted with dried cranberries, chopped nuts, mini-M&M's or crushed candy canes.

CHAPTER OFFICER POSITION DESCRIPTIONS

DIRECTOR:

Per the Official HOG Chapter Charter (US), Article I, the Purpose of a HOG Chapter is to do the following:
1. Promote responsible Harley-Davidson motorcycling activities for Harley Owners Group members by conducting chapter activities and encouraging participation in other H.O.G events.
2. Chapter activities and operations shall be conducted in a manner consistent with a family-oriented, non-political, non-religious philosophy.
3. The Chapter exists to develop a closer relationship between the Harley-Davidson rider and the authorized Harley-Davidson Dealership (meaning, our sponsoring dealership, Fort Thunder Harley-Davidson in Moore, Oklahoma, and by extension, its parent organization, America's PowerSports [APS]).

Additionally, per the Official HOG Chapter Charter (US), Article II, Note 2, a HOG Chapter is part of the Sponsoring Dealership business. This means that the Storm Riders Chapter, and every member of our Chapter, are representatives of Fort Thunder Harley-Davidson.

As such, it is part of your responsibility as a Chapter Officer to ensure that activities, members' behavior, and the way the Storm Riders present themselves to the General Public is consistently done in a manner complying with notes 2 and 3 of the above paragraph.

Additionally, as a Chapter Officer, you have the authority to step in and immediately address any and all individual/sub-group/group behavior that goes against note 2, and/or could bring negative attention to the Storm Riders, Fort Thunder/APS, or the Harley Owners Group. If, in the rare/unlikely event that this happens, you MUST contact the Sponsoring Dealership with a complete accounting if the incident within 24 hours of the incident. Per the Official HOG Chapter Charter (US), Article II, Note 8, "The Dealer may terminate sponsorship of their chapter at any time, at which point the chapter's Harley Owners Group affiliation will cease and desist." To put it another way immature and/or unsafe acts & the Chapter Officers' collective inability to correct the situation without involving the Sponsoring Dealership could result in no more Storm Riders Chapter. Ever. Let's NOT let that happen.

As the Chapter Director, per the Official HOG Charter, Article V, Paragraph 7., Subparagraph BA., the Director "shall uphold this Charter, conduct chapter meetings, and ordinate chapter officer responsibilities." These are your Primary Focus areas.

Furthermore, you are tasked with assisting the General Manager of Fort Thunder Harley-Davidson (FTHD) with any/all matters to help promote both FTHD and the Storm Riders Chapter in a positive manner.

Finally, you are charged with mentoring and guiding the other Chapter Officers so that they can better carry out their assigned duties.

ASSISTANT DIRECTOR:

As the Chapter Assistant Director, per the Official HOG Charter, Article V, Paragraph 7., Subparagraph B., the Assistant Director "shall be responsible for promoting membership, membership orientation, membership retention, and keeping the chapter members informed of H.O.G. programs." These are your Primary Focus areas.

Additionally, you are tasked with assisting the Director with any/all matters to help promote the Storm Riders Chapter in a positive manner.

Furthermore, you are charged with mentoring and guiding the other Chapter Officers so that they can better carry out their assigned duties.

Finally, you are in charge of informing the Chapter Members of upcoming Volunteer Opportunities (Bike Nite Grilling, Saturday Pancake Breakfasts, Christmas Gift Wrapping, etc.), and tracking the hours that each Chapter Member volunteers so that they can get credit towards Dealership Rewards and Chapter Recognition.

TREASURER:

As the Chapter Treasurer, per the Official HOG Charter, Article V, Paragraph 7., Subparagraph C., the Treasurer "shall be responsible for collecting and disbursing chapter funds, reporting financial transactions to sponsoring Dealer/H.O.G. Manager on a monthly basis, compliance with all revenue recording and reporting requirements." These are your Primary Focus areas. **NOTE:** Chapter Funds are generated through Dues, and a variety of fundraising activities throughout the year. Each fundraising source needs to be accounted for separately from all other funding sources (Dues, Pancake Breakfasts, Bike Nite Grilling, Merchandise Sales, etc.)

SECRETARY:

As the Chapter Secretary, per the Official HOG Charter, Article V, Paragraph 7., Subparagraph D., the Secretary "shall be responsible for administering and maintaining meeting minutes, annual reports, membership reports on <u>hog.com</u>, insurance and legal documentation, event releases, and enrollment releases. These permanent records shall be kept at the sponsoring Dealership." These are your Primary Focus areas.

ACTIVITIES OFFICER:

As the Chapter Activities Officer, per the Official HOG Charter, Article V, Paragraph 8., Subparagraph A., the Activities Officer "shall assist in planning and administering chapter events." This is your Primary Focus area.

The Storm Riders Chapter is a big, active Chapter. Once an Activity (except for all "Day Rides") has been approved and entered into the Chapter Calendar, YOU have the responsibility to see that is gets done. However, that does NOT mean that YOU are the only one to do it. You are empowered to recruit "Project Leads" to get more Storm Riders actively involved. For example; when allowed, Pancake Breakfasts, cooking at Fort Thunder events, and Christmas Wrapping are all activities that bring in funds for the Chapter, but as Activities Officer you absolutely can recruit two people to oversee scheduling volunteers and handling all matters pertaining to successfully conducting these activities (and getting all funds raised to the Chapter Treasurer). The "Pignic", "Hog-a-Ween" and "Christmas Party" are the most notable of the Chapter's Signature Events, and each should have their own committees, dedicated to that event's success. You can delegate the Authority to get events done to the high standards the Storm Riders are known for, but the Responsibility for getting Activities scheduled and done rest squarely on your shoulders. **NOTE:** The "Rooster Ride" is a stand-alone activity handled by a committee. As Activities Officer, you will have plenty to work on without adding the RR to your workload.

If, in the joint opinions of the Chapter Officers, there are neither sufficient Volunteers nor resources to properly and safely conduct an activity, ANY activity, we will cancel that activity. Even if it is a Chapter ""

LOH Officer:

As the Chapter LOH Officer, per the Official HOG Charter, Article V, Paragraph 8., Subparagraph A., the LOH Officer is charged with "encouraging women members to take an active part in chapter activities." This is your Primary Focus area.

The Storm Riders Chapter is extremely fortunate to have enough female members to conduct their own "LOH" rides (to include overnight trips), as well as numerous other activities throughout the year. Additionally, the Ladies in the Storm Riders/LOH has taken lead on some of the "Signature Events" each year that makes a good Chapter even better. As the LOH Officer, you are empowered to recruit "project leads" to assist you with both LOH activities, and Chapter activities that LOH has volunteered to take the lead on. You can delegate the authority to get these tasks/events done, but the responsibility for ensuring that they are done safely, and to the high standards that the Storm Riders Chapter is now for, rests squarely on your shoulders. Please coordinate with the Chapter Activities Officer and/or the Head Road Captain to deconflict activities/rides as necessary. Be sure to let the Chapter Director and Assistant Director know who you have put in charge of what.

Head Road Captain / Assistant Head Road Captain:

Road Captains are charged with "assisting with the planning and routes for chapter rides." While not specifically mentioned in the Official HOG Chapter Charter, your role is to select, train, build certify and lead a cadre of first-rate Road Captains. Next, draft up your own "Letter of Expectations" (LOE) for each of your Road Captains, sit down with each one individually BEFORE you start your training & certification process and administer the Letter of Expectations to them, answer any of their questions, and have them sign the LOE. Keep the original, and give the

Road Captain a copy of the LOE. Next, work with your Road Captains to build the Chapter's "Riding Calendar" for the upcoming year. These are your Primary Focus areas.

The Storm Riders Chapter are known throughout the Midwest as having safe, proficient Road Captains that get riders & passengers safely to the day's destination. From the Initial Ride Briefing, setting up the formation and rolling out, to "Kickstands Down" upon arrival at the day's destination, the Storm Riders' Road Captains presented themselves a Professional Team, ready to handle anything.

As Head Road Captain, your number 1 priority is to reestablish and maintain a cadre of strong Road Captains that are uniformly trained, evaluated and certified by you.

Chapter Editor:

As the Chapter Editor, your Duties and Responsibilities closely align with the Official HOG Charter, Article V, Paragraph 8., Subparagraph D., (Editor), where it states responsibility for "assembling and organizing all forms of chapter communications. Ensures all forms of chapter communications are approved by the sponsoring Dealer before publication or distribution" (Note that our Sponsoring Dealership [Fort Thunder] may assign that responsibility to the Chapter Director). Your duties will be to author a monthly Chapter Newsletter highlighting what the Chapter has been up to over the past month,

You may submit ONE person to assist you in your duties managing the Official Storm Riders Chapter #5087 Newsletter. This member must be approved by the Chapter Director, Assistant Director, and the General Manager of our sponsoring dealership, Fort Thunder Harley-Davidson, BEFORE they are allowed to start assisting you.

Safety Officer:

As the Chapter Safety Officer, per the Official HOG Charter, Article V, Paragraph 8., Subparagraph E., the Safety Officer is charged with "providing chapter members with information pertaining to the availability of rider training." This includes briefing at the Chapter Meeting on Motorcycling Safety (you can bring in "Guest Speakers/Subject Matter Experts"), providing all information that lets our Chapter Membership know the where & when of any/all Law Enforcement-sponsored Rider Instruction, and how do our Members sign up for this training. You are to also assist the Head Road Captain in developing their plan to train, evaluate and certify all Chapter Road Captains. These are your Primary Focus areas.

Chapter Lead Photographer:

As the Chapter Lead Photographer, per the Official HOG Charter, Article V, Paragraph 7., Subparagraph P., the Photographer shall be responsible for "obtaining and organizing chapter images for use in chapter communications and chapter history." As Chapter Lead Photographer, you will receive any/all photo and video files from Chapter events, and pass them on to the Webmaster, Social Media Coordinator, Editor, and General Manager of Fort Thunder. You will also be given authorizations to upload, monitor and delete photographs on the official Facebook Page to ensure that any & all images posted to these sites/pages will continue to present the Storm Riders Chapter, our Sponsoring Dealership (Fort Thunder Harley-Davidson), and H.O.G. in a positive light. You will also coordinate with the Chapter Assistant Director on any/all images that may not be appropriate to be published on our website or social media. These are your Primary Focus areas.

Membership Officer:

As the Chapter Membership Officer, per the Official HOG Charter, Article V, Paragraph 8., Subparagraph H., the Membership Officer is charged with "assisting the chapter secretary in membership duties." This includes reaching out to & welcoming new members, maintaining the spreadsheet containing the pertinent information of all chapter members, and putting together/printing/distributing the Annual Directory of all chapter members. These are your Primary Focus areas.

Chapter Webmaster:

As the Chapter Webmaster, per the Official HOG Charter, Article V, Paragraph 8., Subparagraph I., the Webmaster is responsible for "assembling and organizing material for the chapter website, social media sites (if applicable), and obtaining approval from the sponsoring dealer/H.O.G. Manager before publication. Chapter websites and social media sites must comply with the H.O.G. Chapter Internet Guides" (HOG Chapter Handbook, pages 76 - 85). These are your Primary Focus areas. You may submit ONE person to assist you in your duties managing the official Chapter Website.

Social Media Coordinator:

As the Chapter Social Media Coordinator, your Duties and Responsibilities closely align with the Official HOG Charter, Article V, Paragraph 8., Subparagraph I., (Webmaster), where it states responsibility for "assembling and organizing material for the chapter website, social media sites (if applicable), and obtaining approval from the sponsoring dealer/H.O.G. Manager before publication. Chapter websites and social media sites must comply with the H.O.G. Chapter Internet Guides" (HOG Chapter Handbook, pages 76 - 85). Your duties will be to coordinate with both the Chapter Photographer to obtain digital versions of pictures deemed suitable for posting on social media, and coordinating with the Webmaster to ensure all links on our Chapter website are accurate and will take members to our Official Storm Riders Chapter Facebook Page, and any/all other Social Media Venues (Twitter/"X", Instagram, etc.). Additionally, our Sponsoring Dealership (Fort Thunder Harley-Davidson) is required to have a member of their Staff designated as an Administer for ALL of our official Social Media accounts (Charter Chapter, Page 77). Contact the General Manager to find out who this is. You will receive approved photos and videos through the Chapter Lead Photographer and the General Manager of FTHD for use on our Social Media sites. These are your Primary Focus areas.

Chapter Angel:

As the Chapter Angel, your Duties and Responsibilities closely align with the Official HOG Charter, Article V, Paragraphs 4, 5 & 6. Beyond that, your responsibilities include, reaching out to & sending cards and gifts to Chapter Members experiencing serious illness, hospitalization, or other "significant life events". Additionally, if requested, organize volunteers for homemade meals to be dropped off to help a member of the Storm Riders Family that is house-bound due to illness, injury, post-surgery, etc. You may submit ONE person to assist you in your duties as Chapter Angel.

Revenue & Recruiting Officer:

As the Revenue and Recruiting Officer, your efforts are crucial to our Chapter's ability to go beyond only having Chapter Meetings and Rides. Using various techniques within the limits of National H.O.G. Guidelines, and local/state/federal statutes, your efforts in fundraising allow us to provide the bets possible "Storm Riders Experience" at minimal cost to our Chapter Members. Additionally, you will work in conjunction with our Chapter Membership Officer to bring new members to the Chapter, and helping them feel welcome as fledgling "Storm Riders".
